Oct. 8, 2019), the Connecticut Supreme Court affirmed wins in two phases of trial and an extensive Appellate Court decision concerning the allocation of defense and indemnity for asbestos-related personal injury claims across more than 30 years of coverage. The proper exhaustion of primary policies and construction of defense obligations in umbrella and excess policies were among the dozens of issues addressed in these decisions. Similarly, in *Hartford Roman Catholic Diocesan Corp. v. Interstate Fire & Cas. Co.*, 905 F.3d 84 (2d Cir. 2018), the Second Circuit affirmed judgment after a bench trial in which the trial court awarded coverage to a Roman Catholic diocese for settlements of sexual misconduct claims under excess policies.

In addition to being a fellow of the American College of Coverage Counsel, Marilyn is a member of the Insurance Coverage Litigation Committee of the American Bar Association and has held the positions of Chair (2016-2018), Vice Chair and Treasurer of the Insurance Section of the Connecticut Bar Association.


